Ethnic Community Organisations Land Tax Relief Grant Scheme

Guidelines

The Land Tax Relief Grant Scheme is a South Australian Government initiative to assist ethnic community organisations to pay their land tax. This allows them to maintain and build on the community services they provide to their members and to the public.

Organisations can apply for the full amount of their land tax bill.

Eligibility Criteria

Applicants Must

- Be an incorporated organisation registered in South Australia;
- Be a non-government organisation;
- Have an Australian Business Number; and
- Have acquitted any previous grants received under the Ethnic Community Organisation Land Tax Relief Scheme.

Organisations who do not have an ABN will be required to forward to Multicultural SA a “Statement by a Supplier”. Please refer to the Australian Tax Office’s website for more information www.ato.gov.au.

Please note that only applications for the current financial year’s land tax bill will be considered.

The grants are available to cover the cost of land tax for a property owned by:

- not-for-profit ethnic community organisations that are incorporated and have as a primary purpose the provision of service or support for their communities; or
- for-profit ethnic community organisations that can demonstrate financial hardship because of the costs of land tax, are incorporated and have as a primary purpose, the provision of service or support for their communities.

By helping organisations with land tax payments, the South Australian Government encourages them to continue their valuable work in:

- providing social and cultural support to their communities;
- increasing understanding of the culturally diverse State we live in;
- improving the provision of services to their members;
- increasing public participation by South Australians of all backgrounds; and
- celebrating and valuing multiculturalism.

To apply, organisations must send the following to:

- A completed Application Form.
- A copy of their land tax bill.
- A copy of their constitution (if not previously provided).
- A copy of their Certificate of Incorporation (if not previously provided).
- Documentation confirming the possession of an ABN (if not previously provided).
- A copy of their most recent audited financial statement (for-profit organisations only).

Multicultural SA will issue a Recipient Created Tax Invoice, pursuant to “A New Tax System (Goods and Service tax) Act 1999” should the application be successful.”

Those requesting more than \$10,000, will be required to sign a grant agreement.
